Gervais Hearn and the September 11th Memorial - Greenwich

Everyone remembers where they were on that day. I, like many, have a harrowing story. My family and I lived in New York City. That morning the TV was switched on. Cradling my perfect, pink, newborn baby girl, I watched - in horror -- rerun after rerun of my husband's building, next to the Twin Towers, going up in flames. Fighter jets buzzed ominously over our home at the same time.

So many of us have a story in which the ending involves a loved one arriving home safely. We have all heard the accounts of people who were late to work that morning and missed the World Trade Center destruction for any number of lucky reasons. Such is not the case for the family members of 33 individuals with ties to Greenwich, Connecticut who lost their lives on September 11th, 2001.

Gervais Hearn feels it was an incredible honor to have been charged with raising the funds necessary to build the breathtaking memorial that glistens in the sun on the point in Cos Cob Park. In the beginning of the capital campaign she said, "It was difficult because 14 years had passed since the attack." Gervais continues, "One person said to me, isn't it time we forget and move on?" She responded with heartfelt conviction that she believed it was critical that we all remember that fateful day. And, her resolve to fulfill the memorial's mission, which is to honor the memory of the 33 people from the Greenwich community who perished on September 11th, grew more resolute. The memorial is intended to be a valuable educational resource for the region, especially young people, as they learn about this important historical event.

The first phase of the campaign involved raising awareness in the community about the September 11th Memorial Board's plans. Gervais and the Board began by hosting a large, sold out concert featuring Dispatch, The Ian Murray Band and Caroline Jones, all musicians who grew up in Greenwich, and by creating and distributing beautiful Vineyard Vines scarves and ties with the Greenwich Memorial pictured on them. The founder of Vineyard Vines is from Greenwich. Then, a woman who lost a cousin in the terrorist attack, hosted a Soul Cycle spinathon for the memorial and got the town even more excited about the memorial's impact. During this time, Gervais and the Board were making individual donor calls. "The people were unbelievably generous and they all paid it forward," she said. "I would visit a mother, brother or best friend of the fallen who would quickly commit to our project's worth, then give me several more names of friends, who as well, were engaged almost immediately after they learned about the project." Junior Boards were created to raise awareness and funds at Greenwich High school and the Brunswick preparatory School, which raised \$5,000 for the cause.

Designed by Charles Hilton and Associates, the Memorial is made of hurricane proof glass and is fashioned in the image of the twin towers with an American flag motif. The two ethereal buildings

have the victims' names beautifully inscribed on them. This past September 11th the tribute was unveiled during a ribbon cutting ceremony at the breathtaking Cos Cob Park. The day was glorious; the golden sun warmed the friends and family of the departed and the townspeople that joined in the celebration of life. The rippling clear blue water of the Mianus River and vast green marshes served as a serene backdrop to the glistening memorial. Gervais was proud; she, with the Board's assistance raised \$750,000 and the vision for the memorial--"Lest We Never Forget" - has been realized.

Gervais, a resident of Old Greenwich, has recently accepted a new challenge in the Development Department of the Bruce Museum. The Bruce Museum is a world-class institution highlighting art, science and natural history with more than a dozen changing exhibitions each year. The permanent galleries feature the natural sciences with exhibits that range from regional to global. The museum serves 80,000 people a year, of which 15,000 are school-age children, including a number of underserved youth from Connecticut and New York.

There are programs for every age, from Toddler Tours on Tuesday to an afterschool program for students in 9th to 12th grade who have a strong interest in art, to a Lifetime of Learning, a program structured around the premise that people with dementia often have the abilities and desire to participate in, enjoy, and benefit from mentally and visually stimulating activities. The Bruce mobile Outreach programs serve Pre-K through high school students. Programs bring museum objects and live animals to the classroom and engage students in an interactive, object- and inquiry- based learning experience.

Currently on display at the Bruce are: "And Still We Rise: Race, Culture and Visual Conversations," which uses 40 colorful quilts to narrate nearly four centuries of African American history, from the first slave ships to Frederick Douglass, the Tuskegee Airmen, to the first African American president. "Fierce and Fragile: Big Cats in the Art of Robert Dallet," a celebrated French artist, highlights the beauty and allure of big cats and generates a call to protect them in the wild. The paintings were acquired from Hermès' (the fashion designer) own collection and from Dallet's son, Frederic. The exhibition marks an exciting collaboration between Hermes and Panthera, the global wild cat conservation organization.

You may be surprised, based on the fruits of her labor, to know that Gervais was a stay at home Mom until just 10 years ago. She began her transition into the nonprofit world of work by taking the Fundamentals of Fundraising course put on by AFP Fairfield County in 2010. She has also been our AFP Fairfield County devoted Board President for the last 2 years and continues her service, again this year.
