The Director of Development is a key member of the organization's strategic vision. This position requires an exceptionally well-organized and focused individual with related, in-depth, hands-on experience and success in non-profit fundraising including program planning and analysis, event sponsorships, individual giving programs, major donor management, and planned giving. This position works in close collaboration with organizational leadership, including the Director of Communications, Director of Foundation Relations, and the Finance Director.

Responsibilities & Essential Functions

- Collaborate with organizational leadership to craft the annual development plan, related activities and required deliverables/measures of success.
- Develop fundraising programs using historical data and best practices.
- Work to acquire new donors and diversify and expand existing donor landscape, including family foundations
- Secure 3-5 meetings per month for cultivation or solicitation.
- Support the organization in development activities including identification, research and follow-up with donors and prospects, including preparation of letters and materials.
- Consistently work to have meaningful contact with potential donors in the community.
- Collaborate with leadership and staff to identify and cultivate individuals who have the capacity to give to the organization at a major gift level (\$1,000+).
- Research potential sponsors and secure sponsorships for events
- Build a planned giving program
- Manage revenue and expense budget and reporting for development to the Board
